MEMORANDUM AND ARTICLES**

1. NAME OF ALUMNI
Bishop Hall Jubilee School Canada Alumni
2. OBJECTS
 - a. To promote and maintain close bondages among former students, teachers and other staff of Bishop Hall Jubilee School who are now residing in Greater Toronto, Canada. Alumni residing in other cities are welcome.
 - b. To improve the general welfare of members of the Alumni.
 - c. To participate in public, cultural, and charitable activities in communities in Greater Toronto, with the objectives to enhance relationship with the main stream and to promote public image of the Alumni.
 - d. To promote and maintain close bondages between the Bishop Hall Jubilee School Canada Alumni and its mother school in Hong Kong.
 - e. To render assistance and support to its mother school in the provision and improvement of facilities.
3. MEMBERSHIP
 - a. Former students of Bishop Hall Jubilee School.
 - b. Former teachers and other staff of Bishop Hall Jubilee School.
4. RIGHTS AND OBLIGATIONS OF MEMBERS
 - a. To actively support the objects and work of the Alumni.
 - b. To attend Annual General Meeting of the Alumni.
 - c. To vote and be voted at the Annual General Meeting.
 - d. To pay membership fee annually.
 - e. To actively participate in activities organized by the Alumni.
 - f. To notify the Executive Committee in case of change of contact information, i.e., address, telephone number, etc.
 - g. To have access to minutes of the Executive Committee meetings.
5. ANNUAL GENERAL MEETING
 - a. The Annual General Meeting, chaired by the President of the Executive Committee, is held at least once annually. The President fixes the date and venue of the AGM, and notifies all members two weeks in advance.
 - b. The Annual General Meeting requires a minimum attendance of 20% of registered members.
6. EXECUTIVE COMMITTEE:
 - a. The Executive Committee is formed by 7 - 11 members elected at the Annual General Meeting biennially, and their terms of service are two years. Members can stand for re-election upon expiry of service, but maximum term of service is two, i.e. 4 years.
 - b. Elected members will call its first meeting within one month after election, when a President, a Vice-President, a Treasurer and a Secretary will be elected.
 - c. The Executive Committee is responsible to carry out resolutions made at the Annual General Meeting and to look after operation of the Alumni.
 - d. Financial year for the Alumni starts in January and ends in December of the same year. The Treasurer will closely monitor the Alumni's bank account and prepare an annual financial report for the information of registered members at the Annual General Meeting. The bank account has 3 authorized signatories including the President, the Vice-President and the Treasurer, and every cash withdrawal requires 2 signatures.
 - e. The Secretary will assist the Executive Committee in updating the Alumni Directory.
 - f. Minimum attendance for Executive Committee meeting is 50%.

February 8, 2004

The following are the proposed changes to the Alumni Memorandum and Articles:

1. Item (a) of (2) Objects:

It was suggested to change to: "This alumni, with its primary base in Great Toronto, promote and maintain close bondage among former students, teachers and other staff of Bishop Hall Jubilee School."

2. Item (a) of (6) Executive committee:

Because it will very difficult to maintain the normal function of alumni if 6 of the committee members discontinue in next year. Therefore, it was suggested to delete "but maximum term of service is two, i.e. 4 years." in this item.

3. Item (e) of (6) Executive committee:

It was suggested change to "The Executive Committee will update the Alumni Directory."

Bishop Hall Jubilee School Canada Alumni

The 3rd Annual General Meeting of the Bishop Hall Jubilee School Canada Alumni was held on Sunday, February 04, 2006 at 7:00 pm at Times Dynasty Restaurant. Total attendance was 65 including 42 registered members.

Minutes of the Annual General Meeting:

- 1 Alice Chin, Master of Ceremony of the event extended welcome and Chinese New Year greetings to participants. She introduced teachers who were present at the evening including Rev James Chu, Ms Irene Fong, Miss Tsui King Ng, Mr. Hin Shing Wong and Mr. Koon Kau Wong. We started the meeting with our School Hymn led by alumni Adonza Chan, Angela Chan and Edward Leung. Alice Chin continued to introduce members of the current Executive Committee to the participants.
- 2 Business meeting was then started with minutes of the 2nd AGM of the BHJS Canada Alumni held on February 13, 2005 approved.
- 3 May Ho, President of the Alumni reported the work of the EXCO for year 2005. Photo albums of activities held during the year were displayed during her speech, followed by a video of a speech by Mr. Peter Kwok, current Principal, who could not attend our event this year.
- 4 Denise Lam, the Treasurer, presented the financial report for year 2005 prepared by Sharon Wong, Honorary Accountant of the Alumni. The meeting endorsed the appointment of Sharon Wong as Honorary Accountant for year 2006.
- 5 Terrence Kwong, graduate of 1975 was elected as new member replacing Edwin Ng who had resigned from the EXCO lately.
- 6 A total of C\$1356.05 was collected being donation and income from sale of the "Proud to be a Jubilean" CDs, and the money would be donated to the Needy Student Fund of BHJS in HK.
- 7 Special tribute was given to graduates of 1964, 1965 and 1966 to celebrate their 40th + anniversary of their graduation, with their names announced and with toasts. Alice Chin introduced a photo album display of the old school days. Teachers including Rev James Chu, Ms Tsui King Ng and Mr. Koon Kau Wong, as well as alumni Edwin Wong (1964), Winston Chiu (1965) and Anita Kwan (1966) shared their recollections of their old days in BHJS. The most exciting moment was a surprise phone call from Mr. Tai Pang Sen from HK. A souvenir of "Proud to be a Jubilean" CD was presented to the EXCO members and 1964, 65, 66 graduates by the sponsor, Ms Tsui King Ng.
- 8 Winston delivered a thank-you speech on behalf of the 64-66 graduates, followed by words of thanks to the MC from the President.
